CANCELLATION POLICY

Right to Cancel

As part of The Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013 (*13 June 2014*), you have the right to cancel this contract within 14 days without giving any reason.

The cancellation period will expire after 14 days from the date the start date was agreed.

To exercise the right to cancel, you must inform us of your decision by a clear statement, either by post to the above address, or by email to info@parksideroofing.co.uk. You may use the attached model cancellation form, but it is not obligatory.

To meet the cancellation deadline, it is sufficient for you to send your communication concerning your exercise of the right to cancel before the cancellation period has expired.

Effects of Cancellation

If you cancel this contract, we will reimburse to you all payments received from you. We will make the reimbursement without undue delay, and not later than 14 days from the day on which we are informed about your decision to cancel this contract.

We will make the reimbursement using the same means of payment as you used for the initial transaction, unless you have expressly agreed otherwise; in any event, you will not incur any fees as a result of the reimbursement.
